*<sup>1</sup>Prior to a vote being taken on any individual Action Item, or a vote on any other item, public comment will be allowed on the item to be voted on. In the event that the Board member chairing the meeting determines that reasonable rules and restrictions regarding such comment period should be invoked and their view in that regard is supported by a vote of a majority of all Board members present at that meeting, then comments shall be limited as follows: (i) to two minutes per speaker; (ii) for a total of thirty minutes per item; and (iii) with the order of speakers to be determined by the Board member chairing the meeting.
